The route from Beatty Road has the potential to bring a higher crime rate to Whitehall. The bridge could offer an easy escape route from the Whitehall area should a crime be committed.

Woodland Area: There is no study of how this impacts the eco system. A small area of broad leaved woodland on the corner of Jamil and Tram Road would be lost as a result of the proposed works. This woodland area of trees which do harbor a family of deer, foxes and birds.

There are no details to the extent that such routes will cause increased on road wait times for Whitehall residents.

What justifies the construction of this Bridge? The I-20/26/126 crossroads corridor improvement project will not be improved by adding a bridge at Jamil and Tram Roads.
